MRCB Swaps Shares with DMIA to Enhance the Group's Strategic Focus on Current Development Projects

Kuala Lumpur Sentral CBD, 13 April 2015 – Malaysian Resources Corporation Berhad (MRCB) recent share swap deal with DMIA Sdn Bhd (DMIA) will be seen as 2015's top moves by the Group to enhance strategic focus on its current development projects.

This is in line with MRCB's focus on offering innovative and focused development that seek to fulfill the aims of various market segment buyers that appeal to various lifestyle requirements, and at the centre of this focus is the continuous effort to increase land bank holdings that will allow the diverse development ideas to unfold. In a separate proposal, MRCB will dispose its 70% stake in Paradigma Berkat SB (PB) to DMIA for RM39 million, which will in turn allow DMIA to be fully in control of its business direction via PB.
